## ESSENTIAL INFORMATION FOR TRAVELERS ON OLLI'S ALASKA CRUISE TOUR

- 1) <u>Booking procedure</u>: You may sign up for the tour, pay your \$250 deposit, purchase the required travel insurance, and review the State Department's Travel Advisory for Canada and STEP program via the links on the website dedicated to this trip: <a href="https://www.travelgallery.com/olli-alaska-cruise-tour-2024">https://www.travelgallery.com/olli-alaska-cruise-tour-2024</a>. There are up to 40 spaces for our trip, subject to availability at the time you book. **Book early to get the best cabin selection!**
- 2) <u>Travel insurance</u>: All OLLI travelers will be required to purchase travel cancellation insurance. It is recommended that you purchase insurance that also covers pre-existing medical conditions and medical evacuation. Insurance from two different providers, NTA and Travel Guard, is available through the trip's dedicated website (above). Travel insurance also is available through Princess at <a href="https://www.princess.com/plan/princess-vacation-protection/">https://www.princess.com/plan/princess-vacation-protection/</a>. Depending on the policy you choose, we estimate that the required travel insurance will cost about \$300 \$500.
- 3) <u>CDC Recommendations for Cruise Travel; COVID-19 Vaccinations</u>: The CDC recommends that those travelling on a cruise be current on COVID-19 vaccinations. Read these recommendations:

  - "RELEASE OF LIABILITY, AGREEMENT NOT TO SUE, ASSUMPTION OF RISK AND AGREEMENT TO PAY CLAIMS." You need to fill out and mail this form, with your original signature, to trip coordinator Barbara Stocker. She will provide your original to OLLI.
